I. Registration Process Re-enrolling Families

- A. Online Google form for re-enrollment will be emailed to current families January 6, 2026.
- B. Online form includes registration and tuition agreement for 2026-27 year.
- C. Online form can be submitted on a rolling basis but registration fees will be assessed based on deadlines outlined.
- D. Returning Families with a New Student:
 - a. Returning families with new students must have an online registration form submitted by January 16th to be guaranteed a spot in the new class.
 - b. Returning families must complete registration paperwork in addition to online form registration for the new student.

II. Registration for New Families

- A. Families must complete registration paperwork and submit to the school office online or in-person.
- B. Registration forms will be accepted beginning November 13th.
- C. Class assignments will not be confirmed until registration paperwork and fee is submitted.

III. Registration Fees

- A. Registration fees will be based on date of registration form submission:
 - a. Register by February 15, 2026: \$225
 - b. Register by June 5, 2026: \$300
 - c. Register after June 6, 2026: \$375
- B. Registration fees for re-enrolling families will be included with the July Blackbaud tuition charge.
- C. Registration fees for new families must be submitted at time of registration to confirm placement.

IV. 2026-27 Tuition and Active Parishioner Tuition

- A. Tuition Rates will be made available in November 2025
- B. Rates include **Tuition** and **Active Parishioner Tuition**
- C. Active Parishioner Requirements for *Returning Families*:
 - 1. Be a registered parishioner by September 1, 2025.
 - 2. Be active in the life of the parish including Sunday Mass and Holy Days of Obligation.
 - 3. Have contributed to parish financial stewardship via an online platform (Vanco or PushPay) during the calendar year of January 1, 2025 through December 31, 2025.
 - i. Active parishioner stewardship includes contributing financially to the parish intentionally and sacrificially. A suggested starting point is \$20 per week, or \$1,040 annually. Families are invited to prayerfully consider what sacrificial contribution is realistic for their family.
 - ii. Families that contribute less than the suggested \$20 per week may not be considered active parishioners. If you are experiencing a particular financial hardship, contact Pastor, Fr. Phillip Bogacki, or Principal, Nicolle Schroeder, to discuss.
 - iii. Families who did not contribute financially during the 2025 calendar year via an online giving platform will not be considered Active Parishioners.
 - iv. Families new to Christ King School in the 2025-26 school year must have made some contribution to financial stewardship via an online platform on or before December 31, 2025.
- D. Active Parishioner Requirements for *New Families*:
 - 1. Become registered parishioners by September 1, 2026.
 - 2. Become active in the life of the parish including attending Sunday mass and Holy Days of Obligation.
 - 3. Contribute to Financial Stewardship via the website giving page before 12/31/26.

V. Ineligibility for Active Parishioner Tuition Process

- A. If Active Parishioner Tuition is requested by a family, but the family is ineligible due to not meeting requirements, the family will be notified by school business manager Jane Sheehan in March 2026. A new tuition agreement will be required at that time.
- B. Families who requested Active Parishioner Tuition but are deemed ineligible can appeal directly to Pastor Fr. Phillip Bogacki if they believe an error has been made.
- C. Applications submitted after March 15, 2026 will be contacted within 4 weeks confirming requested tuition.

VI. Financial Assistance

- A. Returning families **MUST** submit applications for financial assistance by **April 1, 2026**. Financial assistance will be confirmed by June 5, 2026.
- B. If a family registers and financial assistance is confirmed lower than the family's ask, registration will be void and no fees will be charged to the family.
- C. New families are able to submit financial assistance forms upon registration. After June 5, 2026, financial assistance will be approved on a rolling basis until funding is depleted.
